CORRIGENDUM

As per Rule No. 10 of Notification No. AR-3/Gen-9/97 dated 13th August 2020, in cases where there is an interlocking between any reserved category and PwBD candidate from the Backward Tribe (BT) category, the BT PwBD candidate shall be adjusted against the BT point in the reservation roster.

While applying the said Rule in the CASE 2024 result issued vide Notification NSSB/EXAM-4/14/2023/656 dated 28th June 2025, one candidate each from BT Chakhesang and BT Chang reserved category had to be replaced. Unfortunately, the below mentioned candidates were inadvertently overlooked and the candidates ranking immediately below them were declared successful at the time of result declaration.


