In pursuance of the NSSB ADVERTISEMENT NO. NSSB-4/8/2022(Vol-1)/15 Dated 3rd February 2026, Corrigendum No.NSSB-4/8/2022(Vol-1)/12 Dated 4th February 2026, Addendum No.NSSB-4/8/2022(Vol-1)/29 dated 11th Feb.2026, No.NSSB-4/8/2022(Vol-1) dated 27th Feb. 2026 and on the basis of marks secured by Candidates in the OMR based written examination, the Nagaland Staff Selection Board is pleased to declare the following candidates bearing the Roll Numbers eligible to appear for interview under Combined Educational and Technical Services Examination (CETSE) 2026.

2. Selected candidates for interview may download the **Detailed Application Form (DAF)** and **Annexure-V2** from the official website of the Board and submit along with the **Medical Fitness Certificate** to the Board's Office w.e.f. 10th & 11th August 2026. Candidates who are unable to appear in person may submit through an authorised representative with a letter of authorisation.

3. As provisioned in para 10 of the Advertisement Notification, it is reiterated that, in case at **any stage of recruitment**, it is detected that a candidate does not fulfil the eligibility norms and/or that he/she has furnished incorrect/false information or has suppressed any material fact(s), his/her candidature shall stand **cancelled**.

4. In pursuant to Regulation 34 of NSSB Rules 2020 and as constituted vide Order No.DHFW-8/Misc/Pt-1/2024/1203-09(P) dated 12th June 2026 all shortlisted candidates may obtain the Medical Fitness Certificate from any District hospital w.e.f from 3rd to 7th August 2026. Only Medical Fitness Certificate issued in the District Hospital will be entertained and no other Medical Fitness Certificate will be entertained by the Board.

5. **PwBD candidates** : As per Circular issued by P&AR Dept. vide No. AR-3/GEN-9/97 (Vol-II) dt. 19.12.2024, the certificates of the candidates belonging to PwBDs category shall be re-verified. The date for re-verification will be intimated at a later stage.

6. The personal Interview shall commence from **19th August 2026** and further details will be notified shortly, for which candidates are requested to keep updating themselves by checking the official website: www.nssb.nagaland.gov.in.
